## FERAL PIG UPDATE

The FishHawk Ranch CDDs I and II (we’re in CDD II) have contracted with a new trapper to alleviate the problem with feral pigs in the development.



**The new procedure is to notify Resident Services (813-657-6629) if you notice pig activity, leaving a message on their recorder if they are not open.** Resident Services will contact the trapper to have them monitor the area and the trapper has committed to 24-hour response time.

We in Phoebe Park have seen a decrease in pig activity in the last few months and hope this will continue to improve over the next several months. Please do your part to keep the pigs in control by reporting any sightings and/or damage to Resident Services as soon as possible.

## SIDEWALK/DRIVEWAY ETIQUETTE

You may have noticed that we have several residents who use walkers, push strollers, or walk their pets in the neighborhood on a regular basis. **Our documents require that vehicles NOT block the sidewalks for the safety of adults and children using the walkways.** Please take extra care when parking your cars to avoid this violation of our neighborhood rules.
